



- Asset location
- Information contained
- Function and impact to the business if lost or compromised

Prioritize assets based on: Impact if exposed or breached and level of exposure if unauthorized access occurs Document specific, potential threats to the environment: confidentiality, integrity and availability Standard operating procedures and use cases: Document use case triggers and actions, map threats to service levels and document incident handling procedures, communications and escalations.
