Entity Formation and Dissolution/Liquidation

The liquidation process can result in a number of benefits including cost savings and the removal of the audit requirement.

Economic Substance and Global Tax Transparency



Economic Substance legislation is designed to meet the requirements outlined by the European Union's intergovernmental Code of Conduct Group on Business Taxation, which are aimed at jurisdictions with low or zero rates of corporate income tax. In parallel, CbC Reporting was introduced under the OECD's BEPS Action 13 initiative to enhance global tax transparency by requiring large multinational enterprise groups to disclose key financial information on a jurisdictional basis.

Deloitte assists entities with assessing the application of the relevant legislation and taking steps to ensure compliance with their jurisdiction(s)' Economic Substance and CbC notification or reporting obligations. With experts in direct and international tax, our team is uniquely positioned to combine global market understanding and relationships with local specialist knowledge. Our practitioners have assisted numerous clients with interpreting the Economic Substance and CbC requirements and have extensive experience working closely with the local tax authorities in relation to various regulatory reporting regimes.

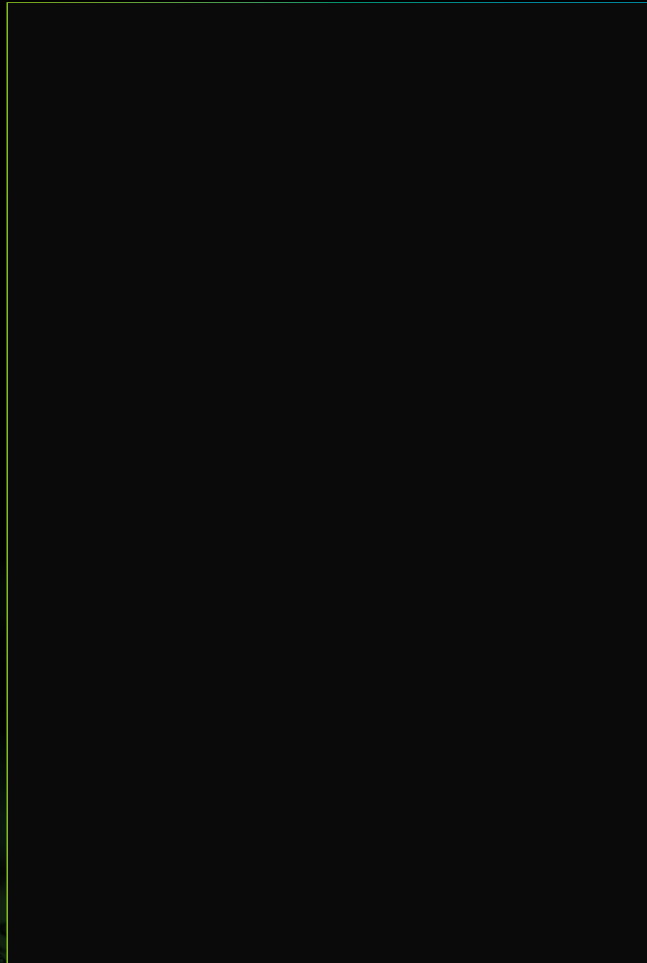
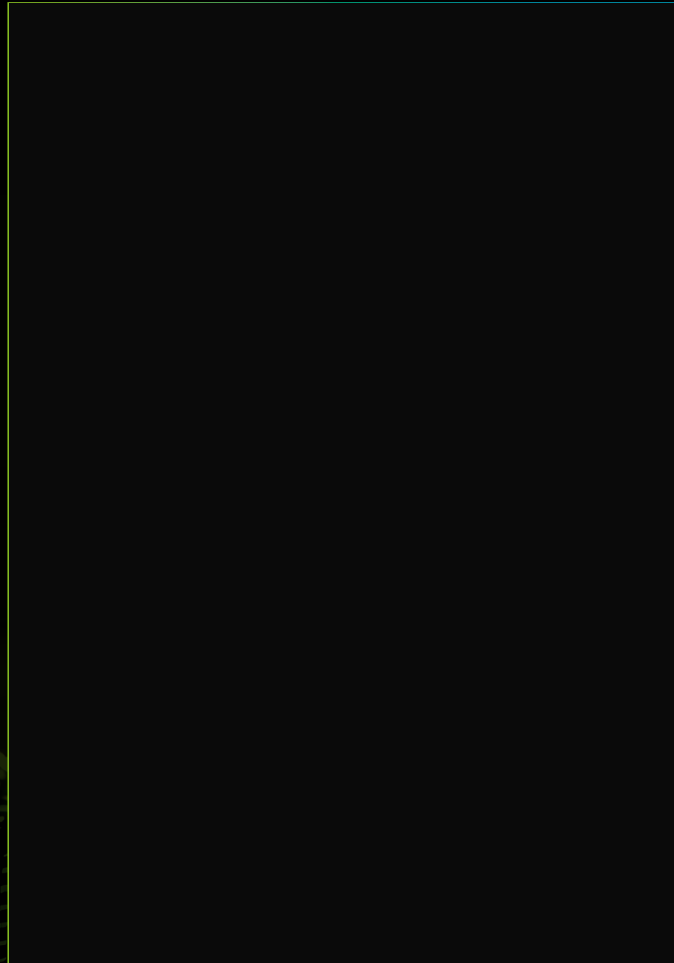
