2. Summary of operations

During the financial year, the net revenue from operations of the Company declined by 75%, from ₹ 14,600 Lakh in the previous financial year 2023-24 to ₹ 3,650 Lakh in the current financial year 2024-25.

The Company's has incurred loss (after tax) ₹ 4,604 Lakh vis-à-vis profit after tax of ₹ 4,840 Lakh in the previous financial year 2024-25, registering a loss of 195%.

3. Transfer to Reserves

The Board of Directors of your Company has decided not to transfer any amount to the Reserves for the financial year under review.

4. Material changes and commitments affecting the financial position of the Company

There have been no material changes and commitments which are affecting the financial position of the Company, between the end of the financial year, and the date of this report.

5. Brief description of the state of the Company's affairs during the year

There has been approx. 75% decline in revenue from operations of the Company during the year as compared to previous financial year, however, the Company expects a steady growth in the business of the Company in coming years. Details of the financial performance of the Company are given above.

6. Nature of business

The Company provides support services in relation to business consultancy, professional, technical and other business services to Deloitte Touche Tohmatsu India LLP in terms of its Master Services Agreement ("MSA") dated March 11, 2015, and any amendments thereof.

There has been no change in the objects of the Company. Business is being conducted as per the objectives described in the Memorandum of Association of the Company. There has been no material change in the line or nature of business that the Company is operating in.

7. Dividend

After careful consideration of the Company's financial performance and future requirements, the Board of Directors has not recommended any final dividend for the financial year 2024-25.
