

How to Request that We Limit the Sale or Use of Your Personal Information

Deloitte¹ (“**Deloitte**”) (also referred to below as "we", "us", and "our") generally does not sell personal information or use it for cross-contextual behavioral or targeted advertising based on your interactions across nonaffiliated websites or online applications (“Targeted Advertising”). In the circumstances where a Deloitte business sells personal information, uses personal information for Targeted Advertising, or uses sensitive personal information (“Covered Activities”), we disclose such practices in the privacy notice applicable to the relevant activity.

Covered Activities (excluding cookie-based Targeted Advertising)

If you are submitting a request not to use personal information for such Covered Activities on behalf of someone other than yourself, please complete our [Personal Information Request Form](#) and include proof that you are authorized to make the request. This may be in the form of a written authorization signed by the person whom you are acting on behalf of or a valid power of attorney.

Cookie-based Targeted Advertising

To request that we not use your personal information for Targeted Advertising that relies on cookies on a Deloitte website, please use the Cookie Settings link on such website to disable such cookies. The Cookie Settings link may be located in the page footer or via the menu bar or application settings. Accepting or declining cookies is limited to such website and will not be reflected on other sites or pages that may be hyperlinked from the website.

Where we engage in Targeted Advertising, our websites detect and respond to the GPC by automatically disabling targeting and advertising cookies set on such websites.
