The University, a large, public, multicampus Research 1 institution, enrolls undergraduate, graduate and professional students. Their annual operating budget is approximately \$2.4 billion, including research and development expenditures. The University employs approximately 14,000.

Following a competitive search to replace its legacy Oracle EBS system, the University selected Oracle Cloud HCM for human resources, payroll, benefits, time and labor and absence management. Considering Deloitte's experience with Oracle Cloud, the University selected Deloitte to lead the implementation and facilitate modernization efforts.

As part of the modernization effort, the University sought:

- Transforming a manual paper-based process with automation capabilities to reduce data integrity issues and completion time.
- Knowledge transfer with the project team and training for the broader community of users.
