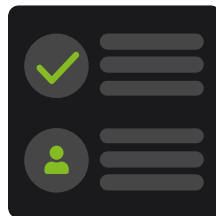


Key Capabilities

Machine learning models provide alerts from social media, news organizations, blog posts, and public forums related to specific entities embedded in your value chains.



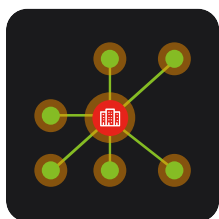
Review financial profiles.

Discover key financial profile data points such as 10Ks, percentage ownership breakdowns, debt to equity, deals with venture capital investors and more.



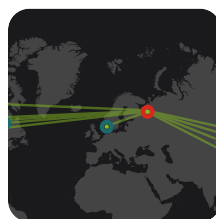
Stay in the know.

Near real-time alerts from social media, news organizations, blog posts, and public forums related to specific entities are embedded in the system, keeping customers up to date about changes in their network.



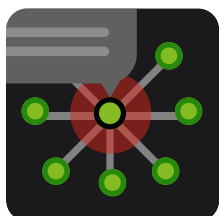
Expose blacklisted companies.
