Use case: Large publicly traded company with global operations

The client, as a current user of the SOXHUB and OpsAudit modules, was utilizing the tool primarily as a file repository. Its control structure wasn't well thought out during initial implementation and its OpsAudit module was too detailed, which led the client's team to have a low adoption of the tool. The client purchased a tier upgrade from AuditBoard and engaged Deloitte to perform the implementation and upgrade of each module. As part of the project, Deloitte advised the client on the features of AuditBoard, leading practices for workflows, and setup of the site. Along side the implementations, Deloitte's business controls and internal audit teams were brought in to provide internal audit and SOX internal control methodology recommendations to provide expanded benefits to the client.

As a result of the project, Deloitte assisted the client with a refresh of its AuditBoard site to increase company adoption and enhanced functionality and dashboard reporting of audits, controls, risks, and issue status. Deloitte advised on leading practices for AuditBoard setup to allow for less administrative tasks on the client team. With the success of the two implementations, the client subsequently engaged Deloitte to perform its initial RiskOversight implementation, which allowed the client to understand and set up the crossmodule capabilities across the platform.
