



## Government fees for 2026 - Update

The reason of this is to inform about the update on the government fees for immigration processes. These fees will be applicable from 1st January 2026 to 31st December 2026.

The new government fees are the following:

- **Obtaining or updating the employer registration certificate:**  
\$391 MXN

- **Work visa or family visa submitted before the INM office:**  
\$294 MXN

- **Border worker visitor through land** (only applicable to those ports of entry through land Quintana Roo, Chiapas and Tabasco):

- Border worker visitor: \$581 MXN

- **Through land, sea or air:**

- Visitor permit without remunerated activities: \$983 MXN

- \*\*The reposition of such document has the same cost\*\*

- **Reception and study of the application and, if applicable, the issuance of the immigration document that accredits a residency condition:**

- Visitor permit with remunerated activities: \$4,341 MXN
- Visitor with adoption ends: \$4,211 MXN

**• Temporal residency:**

- Up to one year: \$5,570 MXN / \$11,131 MXN (Rate at 50% / 100%)
- Two years: \$8,347 MXN / \$16,963 MXN (Rate at 50% / 100%)
- Three years: \$10,571 MXN / \$21,143 MXN (Rate at 50% / 100%)
- Four years: \$12,529 MXN / \$25,058 MXN (Rate at 50% / 100%)

**• Permanent residency:** \$6,789 MXN / \$13,579 MXN (Rate at 50% / 100%)**• Change of status condition:**

- Reception and study of the application and, if applicable, the issuance of the immigration document that accredits a residency condition: \$1,847 MXN

**• Regularization process of the immigration situation:**

- Reception and study of the application and, if applicable, the regularization of the immigration condition: \$1,847 MXN

**• Certificates, permits and authorizations:**

- Exit/reentry permit: \$591 MXN
- Authorization to perform remunerated activities to a temporal residency or student temporal resident (work permit): \$4,341 MXN
- Authorization of the temporal resident condition, when the foreign national accredits being a minister of a cult or belong to a religious association, per year: \$1,369 MXN
- Minor Exit Authorization Form for Mexican nationals and foreign residents in Mexico: \$294 MXN

criteria for applying the **50% or 100%** fee rates are still pending definition and formal publication by the National **Institute of Migration (INM)**. Once the INM issues official guidelines, we will update this information accordingly.
