# Closing of tax branches, offices and delegations (Escuintla, Guatemala and Sacatepéquez)

---

On 09 July 2025, Government Agreement number 116-2025 was published in the official gazette, which indicates that due to the seismic activity in the country, paid leave is granted on 09 July 2025 to the civil servants working at centralized and decentralized public administration entities, specifically in the departments of **Guatemala, Escuintla and Sacatepéquez**.

In this respect, the Tax Administration announced through resolution No. SAT-DSI-1106-2025 of the Superintendency of Tax Administration that the tax branches, offices and delegations will be closed in the departments indicated above. Consequently, 09 July 2025 shall be considered as a non-business day for the

calculation of terms established in the tax, customs and administrative legislation only in the departments of Guatemala, Escuintla and Sacatepéquez.

It is important to mention that customs and all other tax branches, offices and delegations in the country will operate as usual, according to their regular schedule.

It is worth mentioning that some taxpayer assistance services will be provided online only, returning to in-person activities on 10 July 2025.
